Winter Retreat (WR) has been a CEG, London tradition for many years. It is a great time to get away to stitch, socialize, shop, laugh, EAT, read, relax and get to know your fellow Guild members better.

Once again we will be hosting this year's WR at Rainbow Lake Camp Trillium just outside of Waterford. The facility has all the amenities we need for a wonderful retreat: a very large common room for gathering together; a dining hall for our meals and staff who prepare all of those meals. The 7 winterized cabins are side-by-side, and each side contains 3 bedrooms, a common area, one full bathroom and a half bathroom.

There are bunk beds in the cabins, but the top beds are not included in any of our bookings. The rooms will be booked for either single or double occupancy. Camp Trillium is barrier-free. For our outdoor enjoyment there are trails for walking, cross country skiing or snowshoeing. Please bring your own outdoor equipment.

Rainbow Lake Camp Trillium is a specialized camp for children with cancer, and focuses on patients/survivors and their families. The camp is "nut-free," so please do not bring any of your own food onto the property.

WiFi is available in the main building.

Attendance again this year is overnight, with the option of arriving on either Thursday or Friday and staying through until Sunday. **Canadian Embroiderers' Guild, London:  
Winter Retreat Participation & Waiver of Liability Agreement (the "Agreement")**

I, \_\_\_\_\_ [print name] will be participating in the Winter Retreat sponsored by the Canadian Embroiderers' Guild, London, to be held at Camp Trillium, Rainbow Lake, Waterford, Ontario, on one or more dates during the period \_\_\_\_\_ dates \_\_\_\_\_ (the "Winter Retreat").

**IN CONSIDERATION** of my participation in the Winter Retreat, I hereby agree as follows:

1. TO WAIVE, INDEMNIFY AND HOLD HARMLESS, RELEASE AND FOREVER DISCHARGE Camp Trillium, Rainbow Lake, its staff, representatives, agents, volunteers, successors, or assigns and/or the Canadian Embroiderers' Guild, London, and its volunteers, staff, representatives, agents, successors, or assigns (collectively, the "Releasees") from and against all actions, causes of actions, demands, torts, and all claims whatsoever arising out of my participation in the Winter Retreat.
2. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Releasees and to release the Releasees from any and all liability for any loss, damage, expense or injury, including death, that I may suffer or that my next of kin may suffer, as a result of my participation in the Winter Retreat.
3. TO ASSUME ANY AND ALL RISK of death, loss, liability, damage or costs, including my personal injury, death, property damage or loss that may arise out of or in connection to my acts and/or omissions.
4. TO HOLD HARMLESS AND INDEMNIFY the Releasees for any and all liability for any property damage, loss or personal injury to any third party resulting from my participation in the Winter Retreat.
5. TO CONFIRM that my participation in the Winter Retreat shall be in compliance with all of the rules and regulations of the Releasees specifically including Camp Trillium's prohibition on bringing food products of any kind onto camp property, including any camp buildings.
6. TO CONFIRM that this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity.

This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein.

I CONFIRM THAT I HAVE READ AND UNDERSTOOD THIS AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
